



# SCOTT COUNTY FARM BUREAU SCHOLARSHIP APPLICATION

## **Eligibility Requirements:**

- 1) Parents must be a Scott County Farm Bureau member for at least one year.
- 2) Must be a high school senior.
- 3) Must pursue a degree or technical certification at an accredited institution (4 year, 2 year, or Technical school-1 year).
- 4) Must have an overall GPA of at least 2.0 on a 4.0 scale.
- 5) Must have been a participant in at least one extra curricular club or organization.
- 6) Must enroll in the fall semester of the year of application to receive full scholarship. Enrolling in the following spring semester entitles recipient to half of scholarship.
- 7) Any scholarships unclaimed within the two semesters following awarding of scholarship, will be forfeited.
- 8) Scholarships to any program other than 4 year degree programs will be awarded half the value.

## **Information Required:**

- 1) A transcript of all your high school grades, certified by high school counselor, and a copy of your ACT composite scores.
- 2) Include a typed essay, 500 words or less , written by the applicant expressing reasons and desires on "Why I want to further my education."
- 3) Two letters of reference from someone other than family members must accompany application.
- 4) A picture of the applicant must be included suitable for the newspaper.

### **Note:**

- \*Scholarship recipients will be announced at the Awards Night activities.
- \*If scholarship recipient does not enroll in indicated school or program, scholarship may be reduced or revoked.
